- 1. This Invitation for Bids (IFB) follows the General Procurement Notice for this Project that appeared in *Development Business* on July 2, 2007.
- 2. The Republic of Macedonia has received a loan from the International Bank for Reconstruction and Development toward the cost of Agriculture Strengthening and Accession Project, and it intends to apply part of the proceeds of this loan to payments under the under the agreement(s) resulting from this IFB: Supply and installation of Hardware and Application Software for Agriculture Market Information System (AMIS) MK-ASAP-C1-ICB-G11.
- 3. The *Ministry of Agriculture, Forestry and Water Economy* serves as the implementing agency for the project and now invites sealed bids from eligible Bidders for integration, customzation and installation of the system, training, technical support and maintenance of the following information system:

LOT#2: Application Software for AMIS

The intention of the Ministry is to set up an integrated administrative AMIS system of agricultural holdings and agrobusiness companies as an umbrella system over all other registers and systems carrying the information important for effective decision making and implementation of direct planing and payments policies. The AMIS will form the basis for managing national and EU support schemes for payments. The main purpose of the integrated AMIS is to link and thus reporters, registers, systems from one side and users from the other side.. The AMIS system will provide additional data for policy analysis and planning. The AMIS system should be

developed on a reporter level, supported by appropriate IT technology (hardware and software), and fed by data from the relevant available and furture databases for the AMIS.

For successful implementation of the AMIS, it is crucial that data entry and updating is placed to the local level to establish close relation with reporters in agriculture. For efficient management of the system, the system should be put in place to assure central management.

The AMIS should be developed in such way, that it forms the basis for managing and at the same time improves the basis for policy analysis, business planing in the agriculture and CMO(common market organization).

Majority of activities concerning the integrated AMIS is performed on the local level from office's reporters incountrywide. The system should also support the remote work-post approach which enables every reporters to use his/her information and office support tools everywhere in the system and especially in the main offices. The users of the data are: guests (outside users), reporters, managers.

4. Bidding will be conducted using the International Competitive Bidding (ICB) procedures specified in the World Bank's Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004, revised October 1, 2006 and is open to all Bidders from eligible source countries as defined in the Guidelines that meet the following minimum qualification criteria:

LOT#1:

- (i) Financial capability average annual turnover in the past 3 years in reference to the IT systems contracts at least EUR 200.000. The bidder should submit written confirmation stamped and signed).
- ii) Previous experience The Bidder must have experience of at least 2 contracts of similar size and nature in the past three years, presenting references signed and stumped by the Clients.

LOT#2:

- (i) Financial capability average annual turnover in the past 3 years in reference to the IT systems contracts at least EUR 400.000. The bidder should submit written confirmation stamped and signed).
- ii) Previous experience completed and installed at least 1 system of the similar scope and content (AMIS) in the past five years Bidder must submit minimum 1 written confirmation from customer with short description of implemented AMIS software project.
- iii) Personnel capabilities: the Bidder must have minimum one certified Project Manager with certificate issued from one of the offical certificate authorities, which must be submitted.

The Bidders are required to fulfill all qualification criteria if they are bidding for both lots.

The amount of bid security required is: LOT#1: 37.000 MKD (or 600 EUR or equivalent amount in a freely convertible currency); LOT#2: 86.000 MKD (or 1.400 EUR or equivalent amount in a freely convertible currency). Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address (3) below at 13:02 hours, local time on September 21, 2010.

The attention of prospective Bidders is drawn to (i) the fact that they will be required to certify in their bids that all software is either covered by a valid license or was produced by the Bidder and (ii) that violations are considered fraud, which can result in ineligibility to be awarded World Bank-financed contracts.
