Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004, revised October 1, 2006* and is open to all bidders from Eligible Source Countries as defined in the Guidelines.

Qualifications requirements include: *Completion of supply of Furniture in at least 2 (two) contracts in similar size and nature of this contract for the past three years.* A margin of preference for eligible national contractors *shall not be applied.* Additional details are provided in the Bidding Documents.
