- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business* on July 2, 2007.
- 2. The Republic of Macedonia has received a loan from the International Bank for Reconstruction and Development toward the cost of Agriculture Strengthening and Accession Project, and it intends to apply part of the proceeds of this loan to payments under the Contract for Procurement of Laboratory Equipment MK-ASAP-C3-ICB-G14.
- 3. The *Ministry of Agriculture, Forestry and Water Economy* now invites sealed bids from eligible and qualified bidders for the supply of laboratory equipment, as follows:

Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits, May 2004, revised October 1, 2006* and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
- 5. - 6. Qualifications requirements include: Completion of supply of equipment in at least 1 (one) contract in similar size and nature of this contract for the last three years. A margin of preference for eligible national contractors shall not be applied. Additional details are provided in the Bidding Documents.
